

**ROCKY MOUNT TOWN COUNCIL
SPECIAL COUNCIL MEETING
JUNE 30, 2009**

The June 30, 2009 special Council meeting of the Rocky Mount Town Council was held in the Council Chambers of the Rocky Mount Municipal Building located at 345 Donald Avenue, Rocky Mount, Virginia at 7:00 p.m. with Mayor Steven C. Angle presiding. The following members of Council were present:

Vice Mayor Posey W. Dillon and Council Members Jerry W. Greer, Sr., Roger M. Seale, Robert W. Strickler and Gregory B. Walker

Let the record show that Council Member Lester was not present.

The meeting was called to order by Mayor Angle.

The Town Clerk read for the record the following being present: All members of Town Council as noted: Town Manager C. James Ervin, Town Attorney John T. Boitnott, and Town Clerk Patricia H. Keatts.

APPROVAL OF AGENDA

Prior to the meeting, Council had received the agenda for review and consideration of approval.

- Motion was made by Council Member Strickler to approve the agenda as presented, seconded by Council Member Walker and carried unanimously.

REVIEW AND CONSIDERATION OF APPOINTMENTS TO TOWN OF ROCKY MOUNT PLANNING COMMISSION

The Town Manager informed Council that there are three vacancies coming up, with a number of names being submitted in which individuals have expressed a willingness to serve, and at this point, it would be appropriate to nominate folks for the Commission.

Council Member Walker questioned if there was a need for a nomination now, with the Town Manager confirming to the Mayor that Council already had the names, and also stating that the previous discussion was to reappoint Mr. Jerry Greer and the current Chairwoman (Janet Stockton), and to also to appoint for a new term Mr. Bobby Cundiff.

Council Member Greer asked if a motion was needed, with the Town Manager stating that it was entirely optional, with the Town Attorney stating that a motion and second was needed to a motion. Council Member Walker asked if each name needed to be one at a time, with the Town Attorney and Town Manager stating that Council could do a slate of names one at a time. With this being stated, Council Member Walker stated he would make that motion. The Town Clerk asked Council Member Walker to state the motion for the record.

- Motion was made by Council Member Walker to nominate Jerry Greer, Janet Stockton, and Bobby Cundiff to serve on the Planning Commission, with motion on the floor being seconded by Council Member Greer. The Mayor stated that a motion and second was on the floor to reappoint Jerry Greer and Janet Stockton, with Bobby Cundiff moving into the slate that was vacated due to the death of Milton Arrington. There being no discussion, let the record show that the motion on the floor passed unanimously by those present.

At 4:05 p.m., motion was made by Council Member Seale to adjourn, seconded by Council Member Walker and carried unanimously by those present.
